Subject: Review Ordinance 19-1 Setting Fees for Cost Recovery of Fire & Life Safety

Activities

Background

In 1997 the District adopted Ordinance 97-1 Establishing Fire District Fee Schedule. The Board of Directors adopted this ordinance to shift the financial burden from the general public for certain Fire & Life Safety Activities including, but not limited to, providing reports, pyrotechnics for movies or public display, State mandated inspections, new construction, etc.

In 2015, the District adopted Ordinance 15-1 Setting Fees for Cost Recovery of Fire & Life Safety Activities.

Fire prevention activities are some of the most cost effective activities the District is involved in. When fires and other life threatening incidents can be prevented from occurring, there is a significant savings to the community for direct and indirect costs.

The fees are established in order to obtain cost recovery for those activities outlined within the Fire Code. Per the Health & Safety Code, they do not exceed our actual costs. District staff has updated the Cost Recovery Schedule to better reflect the services provided and revised the fees to ensure the amount charged is equal to the amount required to perform the work. As well we have reviewed and adjusted some of the amounts based on the time required to complete certain tasks.

Attached is a draft of the Ordinance which reflects an increase in the hourly rate charged from \$80 per hour to \$140 per hour. We will bring this ordinance back at the next board meeting or at least 30 days later, whichever comes first; at that time the Board will hold a public hearing and consider adoption of the ordinance.

Ordinance Setting Fees for Cost Recovery of Fire & Life Safety Activities

WHEREAS, Meeks Bay Fire Protection District is a Fire Protection District duly organized and existing under the Fire Protection District Law of the State of California; and

WHEREAS, the District is authorized by the provisions of California Health & Safety Code Section 13869 [adopting fire prevention code] to adopt and enforce ordinances relating to the prevention of fire within the District: and

WHEREAS, the District is authorized by the provisions of Health & Safety Code Section 13916 to charge a fee to cover the cost of any service which the District provides or the cost of enforcing any regulation for the fee is charged; and

WHEREAS, the amount of fees shall not exceed that amount reasonably required to administer or process such permits, certificates, or other forms or documents, or to defray the costs of enforcement; and

WHEREAS, California Health and Safety Code Section § 13862 provides that a district shall have the power to provide the following services:

- (a) Fire protection services.
- (b) Rescue services.
- (c) Emergency medical services.
- (d) Hazardous material emergency response services.
- (e) Ambulance services, pursuant to Division 2.5 (commencing with Section 1797).
- (f) Any other services relating to the protection of lives and property.

WHEREAS, the Board of Directors of Meeks Bay Fire Protection District has determined that it is necessary to provide plan review and inspections for various activities regulated under the California Fire Code, California State Fire Marshal regulations, El Dorado County Fire Code and the Meeks Bay Fire Prevention Code within the legal boundaries of the District; and

WHEREAS, the Board of Directors of Meeks Bay Fire Protection District has determined to adopt a revised cost recovery fee schedule for certain activities related to fire prevention and other services provided by the District as a matter of policy.

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of Meeks Bay Fire Protection District that:

- 1. The Schedule of Cost Recovery Fees for services, attached hereto as Exhibit "A" and incorporated herein by reference, is hereby adopted as the rates to be charged for those listed activities by the District.
- 2. The Fire Chief's designee, shall have the authority to waive any Cost Recovery Fee, in full or in part, upon application of an affected party and showing of special, mitigating circumstances. The Fire Chief's decision on application for a waiver may be appealed to the Board of Directors at their next regularly scheduled meeting following the decision.
- 3. This Ordinance accordingly is adopted at the February 27, 2019, meeting, with the new rates to be effective 30 days later.
