Other March Activities

Testify in support of the staff recommendation for an adaptive management approach to achieving TRPA's Transportation and Sustainable Communities Threshold Standard 1 (TSC 1), as opposed to TRPA imposing a "no new net VMT" requirement on new and environmental redevelopment projects within the Tahoe Basin.
- Attend (in person) March 29 meeting of the Tahoe Transportation Implementation Collaborative. Discussion re: timeline for developing TRPA's Regional Transportation Plan (RTP) update, project inclusion, funding assumptions, and next steps.
- Support planning for the MAC/TFFT Leadership meeting scheduled for the Morning of Thursday, April 4th at North Tahoe Fire Station 51.

•Note: The USDA Forest Service, TRPA, and the Lahontan Water Board have released the Final Environmental Impact Statement, Environmental Impact Report (EIS/EIS/EIR) for the Meeks Bay Restoration Project (State Clearinghouse No. 2018092031). The environmental document identifies Alternative 4 as the preferred alternative proposed for adoption by the lead agencies. It includes full restoration of Meeks Creek(Within the project area) and the lagoon, with no pier. It also includes the replacement of the existing State Route 89 bridge over Meeks Creek, non-motorized Lake access features, and changes to upland facilities including expanded parking and the relocation of two motel-style cabins. Only people and organizations who commented on the Draft EIS/EIS/EIR can file an objection on the final environmental document. Objections must be received by the Forest Service (via the LTBMU project website) by no later than May 20, 2024.
