# **CHIEF'S REPORT**

**Fire season outlook:** Last year was pretty quiet in the Sierra range compared to normal. Not as many windy days and pretty lackluster thunderstorm season. This year is expected to more robust; the weather pattern was more similar to the winter of 2018. Locally our high fire danger is expected to come earlier this year, beginning in late June and continuing through November. Following a drier than average winter has really upped the odds of large fires in timber zones compared to recent years, as there is still a lot of dry, unburned, carryover fuels in the Great Basin from 2017-2019 wet winters. Fire season onset depends on spring weather. July onward is the most likely time frame.

District(s)-wide, preparations for this fire season are under way at every level. Contracts and operating plans are being updated and we have a new California Fire Assistance Agreement CFAA in place. The CFAA is the primary mutual aid agreement between the State of California and our Federal fire partner as to how we cooperatively respond, manage and reimburse for auto and mutual aid. Annual firefighter wildfire training is being conducted with all personnel and Incident Qualification Cards (Red Cards) are being issued to qualified personnel. This year our Strike Team Leaders, Overhead personnel and Chiefs received their annual CAL OES training virtually and are now requalified for the season. Administrative staff has been updating our CAL OES annual salary survey and administrative rates. All the while our fleet mechanic has been changing us over from winter to summer operations and servicing our apparatus to insure operational readiness for fire season.

CALFIRE engine 2385 will reoccupy Station 55 in Carnelian Bay on May15th and throughout the fire season and we welcome them back into the District. Having a state engine compliments our local responses while adding an additional level of fire protection to the region. Likely the best news.

Our Public Information Team, in conjunction with our partners at Living with Fire, have been putting out weekly wildfire preparedness messaging that include wildfire preparedness suggested activities you can complete while under the Stay at Home Orders. This month's Chief's corner is on home hardening; the process of preparing your house to resist ember ignition so that it can better withstand an approaching flame front.

# Safety/Wellness and IT


- Health and wellness physicals will be going forward in late May and June.



Re: District Spending Freeze – FY 2019/2020

Date: May 12, 2020

Effective immediately, all discretionary spending is suspended, except for overtime and expenses necessary for the ongoing operations and for business functions of the District. This spending freeze is due to the emergency spending related to COVID-19 and the uncertain financial outlook for the state and county.

On Thursday, May 7, 2020, the Fire Chief, Division Chief Leighton, and the Director of Finance approved known operational expenditures needed for the remainder of this fiscal year. Purchases and expenses approved by the Fire Chief prior to this date are authorized to continue. Any purchases or budgeted items that have not been approved prior to today or obligated to date are no longer authorized and those accounts are now frozen. All invoices over \$1,000 need to be reviewed by the Director of Finance prior to purchase.

Unforeseen or expenditures of an exigent nature should be brought to the appropriate Division Chief for review.

This spending freeze is applicable to the 2019/2020 budget year (May 11-June 30, 2020) and does not currently pertain to the 2020/2021 budget year.

### **Defensible Space Inspections:**

The El Dorado County portion of Tahoma as well as the Glenridge communities were set as "Target Hazard Areas". The goal is to inspect homes for compliance with PRC 4291 and the El Dorado County Vegetation Management Ordinance, while providing outreach, education, and community assistance support. Through the TNFAC program we are also able to identify neighborhood leaders and connect them with the Tahoe Network and Firewise communities coordinator. NTFPD is currently in the hiring process to bring on 2 Defensible Space Inspectors, and starting June 1<sup>st</sup> we will be rolling out Microsoft Bookings on NTFPD and MBFPD websites to allow community members to autonomously schedule a Defensible Space Inspection or Tree Removal Permit.

### **Funding:**

NTFPD/MBFPD will be utilizing Southern Nevada Public Land Management Act (SNPLMA) – Tahoe Network of Fire Adapted Communities (TNFAC) Grant funding for all things defensible space and chipping related. This is the 3<sup>rd</sup> year that this TNFAC grant has covered the costs of chipping and we are currently expecting to utilize this funding source for the next 3-4 years.

## **Chipping Agreement**

NTFPD renews a one-year agreement via MOU annually with NLTFPD to contract their crews to perform the chipping service. NTFPD also seeks hourly cost recovery for both the NTFPD and MBFPD towed chipper trailers to cover repair, maintenance and fuel costs.

SUBJECT: PRIVATE PYROTECHNIC DISPLAYS

#### Background

An informational request from the MBFPD Board regarding contractors hired for private pyrotechnic displays was relayed to Division Chief McNamara. Research with El Dorado County Deputy CAO Sue Hennike and District staff determined the following information.

1. El Dorado County Code Chapter 8.08 Fire Prevention Section 8.08.050 places restrictions on all fireworks in the county. Any public fireworks display must be authorized by written resolution of the Board of Supervisors.

Sec. 8.08.050. - Fireworks restricted.

Any person who uses, discharges or possesses any fireworks as defined in Health and Safety Code § 12511 within the unincorporated territory of the County is punishable according to the general penalties described in Chapter 1.24.

Exception. The provisions of this section shall not apply to any person engaged in the preparation for or performance of public fireworks display authorized by written resolution of the Board of Supervisors in advance in full compliance with any conditions or restrictions contained in such resolution.

- 2. District prevention staff are not aware of any planned or past permitted public fireworks displays in the MBFPD area.
- 3. In the event of a private or public pyrotechnic display in the MBFPD area or on Lake Tahoe District staff would invoke a permit and inspection process consistent with
  - a. El Dorado County Code
  - b. California Health and Safety Code, Section 12500 12759
  - c. Title 19, California Code of Regulations, Chapter 6
  - d. Title 27, Code of Federal Regulations part 55, Sub-part K
  - e. Title 13, California Code of Regulations, Selected Sections
